I. DEFINITIONS AND INTERPRETATION

Electronic Waste (E-Waste) - The term E-Waste will refer to the below mentioned electrical and electronic waste for the purpose of this Agreement which includes;

## II. SCOPE OF THE AGREEMENT

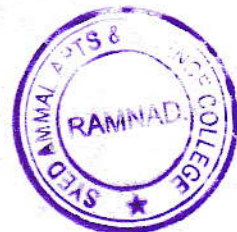
